

**2019 WSOP® Main Event Seat Drawing  
Official Rules**

**NO PURCHASE OR PLAY NECESSARY TO ENTER.** Promotion period ("Promotion Period") begins at 6:00am PT on May 28, 2019 and ends at 11:59pm PT on June 30, 2019. All times referred to in these Official Rules are Pacific Time ("PT"). As used herein, "Casino" means Rio Properties, LLC d/b/a Rio All Suite Hotel and Casino, located at 3700 W Flamingo Rd, Las Vegas, NV 89103. The "2019 WSOP® Main Event Seat Drawing" shall be referred to as "Promotion" throughout these Official Rules. Promotion is sponsored by Sponsor.

**GENERAL RULES:**

1. To be eligible to enter this Promotion, participants ("Participants") must be:
  - a. A Caesars Rewards member (membership is free, and Participants can join at any Caesars Rewards® Center, online at [www.CaesarsRewards.com](http://www.CaesarsRewards.com), or via the play by Caesars Rewards mobile app);

2. 13. 14. 20. Odds of winning dependent upon number of entries received.
21. **PROMOTION REGISTRATION AND ENTRY:**

- 26. To be eligible to win a prize in this Promotion, participants may swipe once to receive one (1) free entry at the Rio Caesars Rewards desk. Participants may earn a maximum of one (1) free entry.
- 27. Additionally, eligible participants may receive entries by buying into between 2 and 5 unique "bracelet events." The buy-in entry breakdown is as follows:
  - a. Two unique buy-ins earns the participant one (1) entry.
  - b. Three unique buy-ins earns the participant two (2) entries.
